TO BUILDING BY-LAW

A by-law in amendment to the Village of Salisbury Building By-Law 36

The Village of Salisbury Building By-Law No. 36 ordained and passed on the 24th day of July 2000 and filed in the Westmorland County Registry Office as number 1118 on August 1st, 2000 is hereby amended as follows:

Subsection 10.(1) (a) (b) is hereby deleted and replaced with the following:

- (a) Building Permit fees for Residential:
 - (i) in the amount of \$ 3.00 per \$ 1000.00
 - (ii) a minimum amount of \$ 25.00
 - (iii) a maximum of \$ 1000.00


- (b) Building Permit fees for Commercial;
 - (i) in the amount of \$ 3.50 per \$1,000.00
 - (ii) a minimum amount of \$ 150.00
 - (iii) a maximum of \$ 2,000.00

- © Demolition Permit Fees
 - (I) \$ 25.00
